

## **United Way of Lake County 2018 Feed Lake County TV Contest Raffle Official Contest Rules**

1. Your United Way of Lake County donation, as described herein, is your entry into the contest. Odds of winning are based on the number of entries received.
2. Donors must be 18 years or older at time donation is made.
3. Donors must contribute a minimum five dollars (\$5.00) to earn a contest entry. Donors will receive a contest entry for every five dollars (\$5.00) donated. Donations must be designated specifically to "Feed Lake County" or "FLC" in order to qualify for a contest entry. Contest start date is March 1, 2018 and contest end date is April 30, 2018.
4. Each contest entry will be entered separately in the drawing. Each contest entry is a separate and equal chance to win the prize specified.
5. If you donate at your workplace, your organization's United Way food drive coordinator will track your donation and supply us with your name and the # of contest entries you've earned. If you donate online at [www.uwlc.org](http://www.uwlc.org) or [www.uwlc.org/feed](http://www.uwlc.org/feed), the contribution form we receive when you click the "Make Contribution" button to submit your donation will serve as your entry into the contest. If you donate online at [www.uwlc.org](http://www.uwlc.org) you must type the letters "FLC" in the notes section of the form. If you donate online at [www.uwlc.org/feed](http://www.uwlc.org/feed) you do not need to do this.
6. The names of all qualified workplace donors must be provided to UWLC by participating employers on a timely basis to be included in the drawing. United Way of Lake County shall not be held accountable for any failure to submit entries. Donors who give online at [www.uwlc.org](http://www.uwlc.org) or [www.uwlc.org/feed](http://www.uwlc.org/feed) as outlined above in contest rule four (#4) are automatically entered in to the contest.
7. Drawing to be held on or about May 4, 2018 during United Way of Lake County's Feed Lake County reception. Winner will be notified by phone and/or email.
8. Participation in the Contest constitutes entrant's full and unconditional agreement to and acceptance of these Official Contest Rules.
